Please have Lucy call me now, even if it's a speakerphone. I would like to say good night to her. Even if she just wants to express that she doesn't want to speak tonight that is fine.

This situation you are causing right now blocking me and preventing contact is entirely not fine.

Based on what the boys told me tonight, I need to address the following immediately:

1. It is not acceptable to have the boys stay overnight and in the care of Richard "Noah" Raulerson given the historic conduct he has engaged in harming our kids. It is mind blowing that you would allow that but pretend to believe I need supervision to see my own children. But regardless of that, he is in no way shape manner or form an acceptable supervisor for the kids. Obviously. Please confirm this will not occur.

2. I haven't been able to speak to Lucy tonight. Our calls are scheduled for 7:30 and you always truncate our calls after a very short period pretending that the children are going to sleep even though they, me, and you are aware they are not. Furthermore, if Lucy could contact me on her phone as required by the court order we would not be having this problem right now. Where is she and why did you not have her contact me as you stated you would?
